Coaching Terms & Conditions

Savvy FC will focus on helping you, the Client. We do not, nor will we ever, receive any kickbacks or financial perks from any other professionals, vendors, companies, or third-party products or services regarding the coaching relationship contemplated hereunder.

Savvy FC will honor your complete privacy. We will not share any personal information, coaching documents, written communications or what we discuss in sessions with any other person without your special specific and written permission, except as may be required by law.

The Client roles and responsibilities:

Client is expected complete pre-session homework to ensure our time together is best utilized. Failure to complete these steps accurately and completely will likely result in fewer or slower results. Pre-session homework may include answering a questionnaire, completing a financial worksheet, reading an educational handout and/or reviewing an instructional video.

Full payment is due ***prior*** to Savvy FC sessions, and we accept ACH payments, credit card payments, or cash (a payment link will be provided). Services will not be rendered until payment is made. You understand that a refund will not be issued. Any exceptions to our no-refund policy will be at the sole discretion of Savvy FC.
